### **Release, Waiver and Assumption of Risk**

I, \_\_\_\_\_, being President or a Director of, (herein called the association), acknowledge and agree on behalf of the Association and its members that in consideration of being permitted to participate in tournaments, programs, clinics, teams or activities organized, operated or sanctioned by the Saskatchewan Racquetball Association (herein called "the SRA"), that I do hereby, on behalf of the Association and its members, release the SRA, its members, officers, directors, employees, independent contractors and agents, from all liability and do hereby waive all recourses, claims, causes of action of any kind whatsoever, in respect of all injuries or losses may be suffered by the Association or its members arising out of or connected with the aforesaid tournaments, programs, clinics, teams or activities, notwithstanding that such injuries or losses may have been caused solely or partly by the negligence of the SRA or any of its members, officers, directors, employees, independent contractors or agents.

And I hereby acknowledge and agree that:

1. The Association and its members freely and voluntarily assume all of the risks and hazards inherent in my participation in the sport of racquetball and that accordingly, my preparation for and participation in the aforesaid tournaments, programs, clinics, teams or activities shall be entirely at the Association's risk or the risk of its members;
2. That I have the power and the authority to act on behalf of the Association and its members and to bind the Association and its members to the clauses of this Form;
3. That I have carefully read this Release, Waiver and Assumption of Risk Form, that I fully understand same; and that I am freely and voluntarily executing same on behalf of the Association and its members;

That the Association and its members clearly understand clearly by my signing the Release, they will be forever be prevented from suing or otherwise claiming against the SRA, its members, officers, directors, employees, independent contractors and agents for any loss or damage connected with any properly loss or personal injuries that I may sustain while participating in or preparing for any tournaments, programs, clinics, teams or activities whether or not such loss or injury is caused solely or partly by the negligence of the SRA or any of its members, officers, directors, employees independent contractors, or agents;
